## ORDER

**Subject: Appointment of Independent External Monitor (IEM) for overseeing and implementation of Integrity Pact in ESIC.**

1. The above appointments are made keeping in view the following references:

- i. CVC Office order no. 021/VGL/011/32735 & no. 021/VGL/011/327356, dated-01.07.2024, respectively regarding appointment of IEMs in ESIC.
- ii. CVC circular no. 015/VGL/091, dated- 14.06.2023 regarding the revised Standard Operating Procedure for Adoption and Implementation of Integrity Pact.
- iii. ESIC Appointment offer letter no. D-13011/1/2022-Genl.(Pt.2), dated-08.07.2024.

2. The Appointment of IEMs shall be governed by the following terms and conditions:-

- **FEE:** The IEMs shall be paid fees @ Rs.25,000/- (Twenty-Five Thousand rupees only) per sitting.
- **TENURE:** For a period of three (03) years w.e.f the date of issue of this order.
- **OTHER ITEMS:** As per Para 6.4 of the revised Standard Operating Procedure for Adoption and Implementation of Integrity Pact, the Department shall provide Secretarial Assistance to IEMs for rendering his/her job as IEM.
- **PLACE OF SITTING:** New Delhi.

3. The IEMs are requested to sign and return the copy of Non-disclosure Agreement and declaration of absence of conflict of interest undertaking (copy attached) within 15 days.

4. Accordingly, all the concerned officer(s) are requested to take the following actions immediately:-

- i. All RFPs/Tenders where the estimated cost exceeds **Rs. Two Crore (2 Crores)**, the names of the IEMs may be suitably incorporated.
- ii. In cases where RFPs/Tenders have already been issued, the appointment of the IEM may be intimated to the concerned vendors immediately and in any case, before the signing of the Integrity Pact.
- iii. If the Pact has already been signed, the concerned vendor(s) may be suitably apprised about the appointment of the IEMs in ESIC at the earliest by the concerned officer(s).
